1.	<u>Actions from last meeting</u>	
34.5	Register a complaint to Locality regarding the poor performance of AECOM during the production of the Site Assessment. CM to progress. Ongoing . To be registered on the 2024/25 grant feedback form to Locality.	CM 34.5
35.4	Tim and Mark will email the members of the Searby cum Owmbly Parish Meeting regarding support for the playground in Searby. Closed . The responses received by 30 th April were all supportive.	
36.3	Regulation 14 requires a mandatory 6-week consultation period with all residents of the parishes regarding the final pre-submission draft version of the Neighbourhood Plan. Closed . See 2.2.	
36.6	A potential solution to the acquisition of the land in Searby for the prescribed purpose of 'community amenity' would be to agree a long-term lease. Ongoing . There is potential to form a local Searby cum Owmbly trustees' group for the lease or to lease directly with Grasby Parish Council. Tim will make enquires and consider the options and next steps. 36.7	The landowner of the Searby site recently enquired on allocating this land as a 'green space'. Chris will seek to understand the repercussions on the provision of community amenities should this be perused. Closed . Included in action 36.6.	
36.9	The steering group activity summary on the parish council website requires an update. Chris and Steve to progress. Ongoing .	CM / SR 36.9
37.1	Nev is to send Chris a list of the statutory consultees the group must engage as part of Regulation 14 consultation on the Neighbourhood Plan. Closed .	
37.2	A zoom call with Helen is to be held at 15:00 on the 7th May. Closed . Chris and Steve attended. See 2.1.	
2.	<u>Progress since last meeting</u>	
2.1	Neighbourhood Plan update: From the discussions with Helen Metcalf on the 7 th May, it would appear the timeline for completion issued last month is no longer achievable given the SEA Screening report must be done after the Regulation 14 consultation period. In addition, two further documents are required before submission for independent review; a Consultation Statement and a Basic Conditions Statement. Helen proposes to write the majority of these documents and expects she will require additional funding above the financial provisions already made by the steering group.	

- 2.2 The aim is to run the Regulation 14 consultation period on the, now completed, pre-submission version of the Neighbourhood Plan from Wednesday, 21st May to Sunday, 6th July. This 6 week and 4 day period satisfies the mandatory time provision set under 'The Neighbourhood Planning (General) Regulations Act 2012.

To meet the targeted start date the following are needed:

- A flyer needs to be produced. Steve and Mike to action – target May 15th.
- Once approved, the flyer needs printing (200 of). Rob will arrange - target May 19th.
- Once printed, the flyer needs to be distributed to every household in Grasby. Chris, Janet, Julie and Steve to progress by May 21st.
- Mark and Tim will email all the residents of Searby cum Owmbly by May 21st.
